Please be advised that starting May 1, 2018, ALL applicants who wish to become a Certified Homemaker-Home Health Aide (CHHA) must apply for initial certification, with the Board of Nursing, **ONLINE only**. Paper applications for initial certification will no longer be accepted on or after May 1st. Additionally, the Board of Nursing has eliminated the conditional/temporary work certification, so ALL applicants **MUST** undergo a criminal background check prior to beginning employment as a CHHA.

Employers and Training Programs should review the letter by the Board of Nursing for detailed instructions. The respective letters can be found on the Board's CHHA **website**.
